High ISSUE

The base of this project is MLM Binary, and there is also an ROI system that gives profit to users on a daily basis.

The contract uses an ROI system and must be considered HIGH-RISK. Users' principal deposits cannot be withdrawn. Users can get dividends and referral commissions. Dividends are paid from deposits of other users. Do always invest with proper knowledge and investigation.

General description of the contract

The **METARISE** smart contract provides the opportunity to Invest 50 USDT in the contract and receive referral profit from direct referral as well as from subsets in one level.

Project is of binary MLM type, and after paying 50 USDT to the contract, this 50 USDT will be distributed among uplines, and users can claim their reward on Claim & Reactivate.

Contract Owners Fee

Activate: 5 USDT Claim & Reactivate: 10 USDT

Owner privileges

The list of functions in the contract that only the owner can call.

- activateProject()
- setMaxSearchAddress()

Profit distribution

When the user activates, the activate amount (50 USDT) will be distributed as follows:

- 10 USDT will be given to the direct referral
 - o This amount reaches the user whose ID was used to join.
- 5 USDT will be sent to the owner's wallet
- 30 USDT will be given to the user's main upline in one level

Each user can only have three direct referrals; if three positions of each user are filled, the user who has joined will be placed under the closest sub-set of the upline user.

Note: When the user's profit reaches 90 USDT, the user will be deactivated and must reactivate to receive profit again.

In Claim & Reactivate:

- 40 USDT will be sent to the user as a reward.
- 30 USDT will be given to the user's main upline in one level
- 10 USDT will be sent to the owner's wallet

There is also an ROI system in addition to the Binary MLM system, which gives users a 2% daily profit on the amount of activation (50 USDT).

- The maximum ROI profit for users is 200% (100 USDT)
- If the user has reactivated twice, the user's ROI profit will be stopped.
